Leak Detection Services Include

- 1. Enchanting Pools KC will perform a leak detection / pressure test of the pool, plumbing and equipment. Will also do a listening test with specialized audio equipment.
- 2. After the leak detection / pressure test is completed we will provide a basic report of finding.
- 3. We do not make any repairs during leak detection / pressure test.
- 4. It is understood and agreed that this inspection and pressure test will be of readily accessible areas of the pool/spa and is limited to visual observations of apparent conditions existing at the time of the inspection only. Any item concealed which requires mechanical disassemble are examples of inaccessible areas. Latent and concealed defects are deficiencies are excluded from the inspection; equipment items and systems will not be dismantled.
- 5. Maintenance and other items may be discussed, but they are not part of our service.
- 6. The report is not a compliance inspection or certification for past or present governmental codes or regulations of any kind. The inspection and report do not address and are not intended to address the possible presence of or dancer from any potentially harmful substances and environmental hazards.

1. Preform a bucket test prior to calling to schedule a Leak Detection.

Bucket Test:

- Bring pool water to normal level.
- Fill a 5 gallon bucket with your pool water about 3 to 4 inches from the top.
- Place the bucket on the first or second step of the pool (preferable second step without immersion).
- Mark the water level on the inside of the bucket with marker or electrical tape.
- Shut off pool pump and mark the pool water level on the outside of the bucket. Turn pump back on after marked.
- After 24 hours, compare the two levels. If the pool water (outside mark) goes does more the inside water level, there may be a leak.
- 2. If you determine there is a possible leak call us.
